Purpose of the Report

For members to consider an application for financial assistance to Huish Episcopi and Langport Cricket Club for enhancement of cricket facilities.

Public Interest

Huish Episcopi and Langport Cricket Club have applied for financial assistance from the Area North community grants scheme. The application has been assessed by the Community Development Officer who has submitted this report to allow the Area North Committee to make an informed decision on the application.

Recommendation

1) Approve the award of £3,000 to Huish Episcopi & Langport Cricket Club towards Enhancement of cricket facilities, allocated from the community grants budget subject to the SSDC standard conditions for Community Grants (Appendix A) and the following special condition:

Background Information

Langport is one of the four market towns in area north with a population of 1050. The parish of Huish Episcopi with a population of 1900 boarders Langport. The cricket club attracts members from both communities and other surrounding villages.

Project development

This is a natural progression for the club to enhance the facilities and coaching needs of the players for out of season practice as well as normal in season training.

Project description

To install a fully carpeted double bay practice facility size 26mx7.3 with associated safety netting

Anticipated benefits and outcomes

As with any community sport and coaching plays a major part in improving the skills and achievements of individuals and enhancing team performance. This facility will allow all year round training and coaching to take place across the entire membership.

Business Plan

A sinking fund for repair and replacement is to be set up

The club is affiliated to the England and Wales Cricket board. All sections of the club have representatives on the management committee who have a sound constitution and good financial control. There is 21 years left to run on the lease.

Evidence of support for the project / consultation

The Community Health and Leisure Service (formerly Sport, Arts and Leisure) fully supports the community grant application submitted by Huish and Langport's Cricket Club for funding towards a 2-lane practice facility. The club has developed from one U13 junior team in 2004 to eight junior teams in 2009, including a new girls team. They have been awarded with the English Cricket Board Clubmark accreditation. Clubmark is a nationally recognised club development scheme run by Sport England in partnership with sporting National Governing Bodies (NGB's) to recognise high quality sports clubs with junior sections.

The club is extremely pro-active in linking with local schools to increase the number of young people being guided into clubs, including its head coach delivering four hours of coaching at Huish Primary School in the Summer Term. The club is an active member of the South Somerset Cricket Development Group, which is overseen by SSDC to lead the development of Cricket across the district.

Our Strategy for Sport and Active Leisure in South Somerset 2006-2012 adopted by full council clearly sets out policy areas to increase participation in sport and improve junior performance levels by increasing junior representation at county, regional and national levels. In order to achieve this it is essential that local people and sports clubs are able to access adequate and affordable facilities within a reasonable distance. This all-weather facility will enable the club to offer further coaching sessions to junior members and provide an affordable option for training, which will improve the performance of players at the club.

Indoor training facilities are an option, which are often too expensive for cricket clubs to train all year round, this facility is therefore crucial to deliver an all year programme of cricket and ensure young people have access to opportunities to take part in sport and physical activity.

Community Grants Assessment Score
