## Purpose of the Report

To inform Members of the actual spend against budgets for 2009-10 of the services over which this Committee exercised financial control.

#### **Public Interest**

This report gives an update of the Area North Committee's financial outturn for the twelve months ended 31 March 2010.

- (5) Note the position of the Area North Community Grants budget, including details of grants authorised under the Scheme of Delegation by the Area Development Manager (North) in consultation with the ward member(s) (Appendix C).

## **REVENUE BUDGETS**

#### Background

Full Council in February 2009 set the General Revenue Account Budgets for 2009-10 and delegated the monitoring of the budgets to the four Area Committees and District Executive. Area North now has delegated responsibility for the Area North Development

revenue budgets, which include revenue grants and regeneration, the Area North Capital Programme and the Area North Reserve.

#### **Financial Position**

The table below shows the position of revenue budgets as at 31 March 2010. This includes transfers to or from reserves. It also includes the carry forwards agreed by District Executive in June 2009.

**NOTE**: Requested carry forwards for 2010 will be considered by District Executive in July.

#### Area Development Manager (North) Comments

Other than a small underspend to support corporate savings the major reasons for variances include £53,780 which has been requested as a carry forward. This includes:

Area North Service Enhancements - £35,700 (Lengthsman £5000; Community Cars £5000; access to services & welfare £10,000; Countryside access £5700; £10,000 unallocated)

Community Grants - £13,970 (offered and accepted, projects to be completed) Community Safety Panel and Martock cycling by-law - £3,110

The 'Grants' budget is for grants made under the SSDC Community Grants Programme and details of the current position are included in Appendix C.

At the time of writing, it is possible that the carry forward requests will not be approved, and instead commitments must be made from the 2010-11 budget. This would reduce the 2010-11 service enhancement budget to around £20,000 and the grants budget to around £16,000.

## **Budget Virements**

Under the financial procedure rules and providing that the Assistant Director-Finance & Corporate Services has been notified in advance, the Area Development Manager can authorise virements for each individual cost centre within their responsibility (as defined by Appendix B of the Annual Budget Report) and Assistant Director/Portfolio Holder can authorise virements up to a maximum of £25,000 between services within their responsibility. All virements exceeding these limits need the approval of District Executive. All virements between different Services, irrespective of value, need approving by District Executive. Area Committees can approve virements between their reserves and budgets up to a maximum of £25,000 provided that all such approvals are reported to the District Executive for noting. (In accordance with the constitution).

## CAPITAL PROGRAMME

The revised capital programme for this financial year and beyond is attached following this report together with a progress report on each scheme either Area or District Wide that are current within Area North.

In summary the actual spend to 31 March 2010 was £121,068 on an approved 2009/10 programme of £239,419. £12,158 of the unallocated programme for 2009/10 was unused. It is recommended that the slippage of £130,509 for both approved and reserve schemes be carried forward into 2010-11.

For future years, there is £110,000 in the main programme and £180,000 in the reserve schemes awaiting allocation.
