Purpose of the Report

For members to re-consider an application for financial assistance to Curry Rivel Cricket Club for the purchase of a powered wicket preparation roller.

Public Interest

Curry Rivel Cricket Club has applied for financial assistance from the Area North Community Grants Scheme. The application was first considered in August, when the Committee decided to defer the application for further information to be gathered.

The application has been re-assessed by the Community Development Officer who has submitted this report to allow the Area North Committee to make an informed decision.

Recommendation

- 1. Approve the award of £1445 towards a replacement wicket roller, allocated from the Community Grants budget subject to the SSDC standard conditions for community grants (see Appendix A) and the following special condition:
 - a) The applicant must make provision for future repair and replacement. SSDC recommends the applicant establish a sinking fund to achieve this condition.

Background

This report is an update to the report first submitted in August 2010 and deferred for further information.

Further Information supplied by the applicant

- The roller pictured in the August presentation was of a roller on hire at a cost of approximately £200 a month totalling £2,400 due to the longer than expected grant application procedure.
- The clubs previous roller was second hand in 1970 and dated back to 1920 it had been regularly maintained and rebuilt twice.
- The proposed new roller is a model approved by the English Cricket Board and attracts a grant of 70% of the cost, The possibility of a second hand road roller is not recommended by the ECB as it dose not have the correct specifications as a cricket roller. See Appendix B

- The roller will be garaged and subject to a regular maintenance regime
- The club has an ongoing development program for junior members
- Increased funding has been agreed by the Parish Council

Background Information

Curry Rivel currently has a population of around 2230. The club was originally established in 1901 and re-launched its junior and youth section five years ago.

The club promotes cricket to young people and adults in Curry Rivel and the surrounding villages. It holds a membership of 116 of which 51 members are 18 years or under. As well as a senior team, the club also runs under 10, under 11 & under 13 teams for girls and boys in the league.

Project development

The project is out of the necessity to maintain a high standard of wicket preparation to enable players both young and old to enjoy and improve their skills

At the beginning of the 2010 season the clubs 1920's power roller failed and could not be repaired. Whilst the club have been submitting funding applications to assist with the cost of replacing the old roller they have been hiring a powered roller at a cost of £200 per month totalling £2,400, which has been a drain on club funds. The Poweroll 12 is a dedicated roller designed for cricket pitches and approved by the English Cricket Board who have made a grant to this appeal.

Project description

To replace the existing wicket roller which was purchased second hand in 1970 and dated back to the 1920's with a Poweroll 12 which is a roller designed for cricket club use and meets the specifications of the ECB grant.

Anticipated benefits and outcome

The replacement roller will assist in keeping the pitch well maintained and in a safe condition enabling the club achieve the following:

- To continue to develop girls and boys cricket and provide courses for new and existing volunteer coaches.
- To develop a recognised coaching pathway and to create a culture of volunteering in order to make a sustainable future.
- To continue to develop primary school links by providing coaching support to primary school lessons and providing an after school club hosted by the club at the ground along with holding the Community Learning Partnership Kwik Cricket tournaments.
- To specifically target girls at an early age in primary schools in order that it becomes the "norm" to play cricket.
- Provide specialist coaching to talented girls in order to fast track their ability.
- To provide coach support to volunteer coaches in order to mentor and develop their skills.

Management and ownership

The Club is affiliated to Somerset County Cricket and England and Wales Cricket Board. All sections of the club have representatives on the management committee who have a sound constitution and good financial control. They currently hold a 20 year lease, which will end in 2030.

Evidence of support for the project / consultation

The Community Health and Leisure Service fully supports the community grant application submitted by Curry Rivel CC for funding towards a new powered roller. The club has developed from no youth teams in 2004 to teams from under 10's to under 16's in 2010; this is in addition to the two adult teams they run. They have been awarded with the English Cricket Board Clubmark accreditation. Clubmark is a nationally recognised club development scheme run by Sport England in partnership with sporting National Governing Bodies (NGB's) to recognise high quality sports clubs with junior sections.

The club is one of Somerset County Cricket Board's Focus Clubs, which are selected on the basis that:

- They are identified as a key deliverer within the County Cricket Board Strategic Development Plan.
- They are committed to delivery of junior development programmes and/or development activities with specific target groups (disability, women/girls, and ethnic minorities).
- They are able to access and utilise ECB, County Cricket Board and local development resources to support the delivery of their club development plan.

This is even more impressive, since the club is based in a small village. The club is extremely pro-active in linking with local schools to increase the number of young people being guided into clubs, with the Youth Co-ordinator Peter Sleightholme leading a pro-active link with Curry Rivel Primary School.

Our Strategy for Sport and Active Leisure in South Somerset 2006-2012 adopted by full council sets out policy areas to increase participation in sport and improve junior performance levels by increasing junior representation at county, regional and national levels. In order to achieve this it is essential that local people and sports clubs are able to access adequate and affordable facilities within a reasonable distance. This powered roller will ensure that the club can maintain it's current pitches to a standard, which continues to encourage the development of players at the club.

Community Grants Assessment Score

Summary and Recommendation

If awarded the SSDC contribution completes the funding required and would allow the project to be completed without delay. The ECB contribution is approximately 70% of the project

Recommendation:

To support the application for the full amount requested.

Financial Implications

The budget for community grants for 2010-11 is £28,360. £1800 has been allocated to date, leaving £26,560. If the recommendation is approved of £1,445 will leave £25,115.
