# **Background**

Background information on the Area North Community Safety Action Panel and the Neighbourhood Policing team is included in Appendix A.

# 1. Neighbourhood Police Report from Sgt Alan Bell:

Avon and Somerset Constabulary (ASC) has recently reviewed how the Neighbourhood Policing team conducts its business, which includes the areas we should focus on. It has been described as a change from neighbourhood policing to policing the neighbourhood.

Priorities and areas of weakness in respect of crime trends will be the primary focus and staff are tasked to deal with issues as they arise. Whilst this is not new to Area North, we will continue to use staff from across the area, if required, to assist in tackling particular problems.

#### **Structure**

There has been movement within the Neighbourhood team since the last report. PC Brand has unfortunately been redeployed due to illness. PC Selley has transferred over to PC Brand's wards to provide some stability and for a while was responsible for a significant portion of the area. I am pleased to say we have secured PC Watson, an experienced Beat Manager from Crewkerne. He has previous experience of managing South Petherton and will now be responsible for that area as well as the Martock and Hamdon wards.

PCSO Olly Hammonds left the organisation and PCSO Rachel Napper who moves from the Hamdons ward has filled his position. PCSO Charlie Rogers moves from the outlying villages of South Petherton to the Hamdons and Rachel will take on those villages.

## **Crime reports and trends**

Area North continues to remain a safe place for our communities to live and work. Reported crime (which now includes Anti-social behaviour (ASB)) remains average for our geographical type of area. The current figures released by the Constabulary are held on individual ward pages on our internet site and can be accessed through the crime mapping section <a href="http://www.avonandsomerset.police.uk/information/CrimeStats/">http://www.avonandsomerset.police.uk/information/CrimeStats/</a>. (It should be noted that as allegations are investigated they may subsequently be reclassified). Parish Councils are issued with crime figures for their parishes on a monthly basis. These are accessible to the public as part of the PC minutes. Should councillors have a specific issue, they can raise this with their Beat Manager or myself.

During the summer as the price of scrap metal increased, we saw a large increase in metal thefts especially around the Langport/South Petherton/Martock triangle. Work was undertaken in building better relationships with local scrap dealers within South Somerset and a number of suspects were identified as being potentially responsible. Following some hard work by not only the Safer Stronger neighbourhood team but other officers and PCSOs across the policing district, a young male, local to Area North, was arrested and has been charged with 3 burglaries, 7 lead thefts and he has asked for 64 other offences to be taken into consideration. He has been remanded in custody to appear before the court.

## **Police Posts**

We continue to have access to the two posts currently at Martock and South Petherton. Martock remains at the Fire Station and is by the neighbourhood team and by others within the policing district. It is acknowledged that the installation of IT and Security at the South Petherton Community Centre has been slower than anticipated or desired. It is still the intention that the neighbourhood team to utilise the centre at every opportunity. This is something the new Beat Manager PC Watson has been tasked with. This will increase the neighbourhood team's visibility and reinforce the beat team's presence in the village and surrounding area. In the long term there could also be benefits to those communities who live in Islemoor; Burrow Hill and Hamdon as the teams covering those areas will be encouraged to use the facilities at South Petherton rather than travel back and forth from Somerton.

## **Neighbourhood Watch (NHW)**

I have been given the portfolio of Neighbourhood Watch for the whole of the southern part of the policing District. There is currently work in progress to establish how many

schemes are still active and whether the co-ordinators are still those shown on our records. The content and number of "Ringmaster" messages has been reviewed. There should now be a consistent approach to what is sent out to Co-ordinators, it should be in plain language and more importantly there will be feedback on the messages we do send to update Co-ordinators. All schemes will be encouraged to participate in the creation of Cold Calling Aware Zones should they feel a need for one and there will be also lead initiatives such as the Nominated Neighbour Scheme. The process to start up new schemes is currently being reviewed so that future schemes, from the start are aware of roles/responsibilities and expectations of both them and the local neighbourhood team.

### **Farm Watch and Horse Watch Schemes**

The Horse Watch scheme continues to be administered on Area North by PCSO Support Officer Tess Smith. Currently there are 192 members registered over the South Somerset Policing Area. Free tack marking and signs are available as well as crime prevention advice for those owners with horses who sign up to the scheme. Farm Watch on Area North currently has 79 members. As we are mainly a rural area with a significant number of farms, each Beat Manager has been tasked with increasing the amount of holdings participating in the scheme. ## 3. Community Justice Panel

The Community Justice Panel has 6 volunteers across Area North all of whom are now fully trained and taking cases. There are a further two volunteers awaiting training in November. The panel has handled 16 cases in Area North, in Langport, Somerton, South Petherton, Martock and Stoke-sub Hamdon.

Julia Cook has been appointed the part-time coordinator for the Area North Panel and will combine that with Area West. Julia will be spending at least one day per week in the area and will hot desk within the council premises in order to have access to the computer system. Coordinators are now in place for all the new panels covering South Somerset and Mendip.

The Community Justice Management Group will meet again in November and it is hoped to combine that with a visit from the Ministry of Justice.

## 6. Football Programme

The Community Safety Partnership via Local Action Groups is currently running successful weekly sessions in South Petherton and Martock where young people can take part in skills training with Yeovil Town Community Sport Trust coaches. In June, Yarlington Housing Group sponsored a tournament between all eight football schemes in South Somerset. Terry Skiverton presented all the young people with a medal and South Petherton won a team award.

## 7. Martock Fire Station Community Event

Local residents enjoyed an action packed evening at Martock Fire Station in July.

All three Emergency Services involving Devon and Somerset Fire and Rescue Service, Avon and Somerset Constabulary and South West Ambulance Service Trust attended this event. It was supported by the Mendip & South Somerset Community Safety Partnership to promote Road Safety Education, community safety advice and the work of the partner agencies.

Rob Mitchell, Chairman of Long Load Parish Council, put himself forward to take the part of a trapped "casualty" in the Road Traffic Collision display and was cut from the vehicle by the Fire Service aided by the Ambulance crew. He added that "it was a very sobering experience, and brought home just how much expertise, care and teamwork is involved on such occasions, and demonstrated the skill and dedication of the officers and paramedics involved from the emergency services."

Watch Manager Alan Potter & Crew Manager John Knight of Martock Fire Station helped plan the event. John said "community safety and community engagement is a big part of the Fire & Rescue Services role and we all enjoy working with partners and communities to make them safer. We all enjoyed the evening and hope to do a similar event soon."
