Purpose of the Report

To inform members that an application for a new premises licence under the Licensing Act 2003 has been received from Natural Communities CIC for specified areas of Gilcombe Farm, Bruton. It is a time limited application from 10:00 Thursday 3 June until 23:59 on Monday 7 June 2010.

Recommendation

To determine the granting of the premises licence in accordance with the options detailed later in the report.

Background

The Council is the authority responsible for the issue of Premises Licences issued under Section 18 of the Licensing Act 2003.

The Licensing Manager has delegated authority to determine a Premises Licence application, subject to no objections being received from a Responsible Authority or an Interested Party. In this case, three relevant representations have been received from Responsible Authorities and eight from Interested Parties, necessitating the convening of a hearing.

Licensing Objectives

The licensing objectives are:

- Prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- Protection of children from harm

The licensing objectives are to be considered paramount and the Council has a duty to promote them in its decision making process. An application will not be refused in whole or part or any conditions attached except those offered by the applicant or required by law except where necessary to promote the licensing objectives.

Interested Parties

Clarification has been sought from Interested Parties concerning the following matters in accordance with Regulation 7(1)(d):

- The severity of the complaint
- Details of any dates and times complaints made concerning the licence granted to Natural Communities CIC for 2009 (if any); to which body the complaints were made e.g. The Environmental Protection Service and/or The Police; and to which Officer
- Proof (if any) that incidents relate to the patrons of the Sunrise Festival

Considerations

In determining the Application with a view to promoting the licensing objectives in the overall interests of the community, the Committee must have regard to and give appropriate weight to the following considerations: -

- Any relevant and valid representation (including supporting documentation received)
- The Latest Guidance issued under s182 of the Act
- Guidance issued under s182 of the Act
- The Statement of Licensing Policy issued in December 2007
- The steps necessary to promote the licensing objectives as set out in s18(4) Human Rights considerations in particular Article 6, Article 8 and Article 1 of Protocol 1

The Committee may depart from the Guidance and the Policy referred to above if the merits of the application require it. Full reasons must be given for any departure made.

Options

The options available to the committee in this case are as follows:

- Grant the licence s18(4)(a)
- Grant the application subject to modification to such extent as the Authority considers necessary for the promotion of the Licensing Objectives and any condition, which must under s19-21, be included in the licence s18(4)(a)(i)(ii).
- Exclude from the scope of the licence any of the licensable activities to which the application relates s18(4)(b)
- To refuse to specify a person in the licence as the premises supervisor s18(4)(c)
- Reject the application s18(4)(d).

Right of Appeal

Schedule 5 of the Licensing Act 2003 sets out the rights and procedures for making appeals against the decision of the Licensing Authority.

Where the Licensing Authority has rejected an application to grant a premises licence, the applicant may appeal to the Magistrates' Court against the decision to reject.

Where the Licensing Authority has granted the licence, the applicant may appeal to the Magistrates Court against any decision to impose conditions on the licence that are consistent with the operating schedule or imposed as steps considered necessary for the promotion of the licensing objectives.

Where the Licensing Authority has granted the licence subject to the exclusion of any of the licensable activities or refused to specify a person as the premises supervisor, the applicant may appeal to the Magistrates Court against the decision.

If the applicant receives a favourable decision from the Licensing Authority, the person(s) making the representation also can appeal to the Magistrates' Court against the grant of licence or that the Licensing Authority ought to have imposed different or additional conditions.

If the applicant receives a favourable decision from the Licensing Authority, the person(s) making the representation also can appeal to the Magistrates' Court on the ground that it ought to have taken a step to exclude a licensable activity or refused to have specified a person as the premises supervisor.

The appellant commences the appeal by giving a notice of appeal to the designated officer for the Magistrates' court within 21 days beginning with the day on which the applicant was notified by the Licensing Authority of the decision appealed against.

On determining the appeal, the court may,

- Dismiss the appeal
- Substitute for the decision appealed against any other decision which could have been made by the Licensing Authority; or

Remit the case to the Licensing Authority to dispose of it in accordance with the direction of the court.

and may make such order as to costs as it thinks fit.
