# Public Fundraising Regulatory Association PFRA – Site

The Licensing Officer summarised the report, which updated members on the monitoring and performance of the site management agreement with the Public Fundraising Regulatory Association (PFRA) in relation to face-to face fundraising.

The Licensing Officer informed Members that the Site Management Agreement was amended to include Yeovil Town in March 2012. Since March 2012, the PFRA had administered 77 face-to-face fund raising collections and that 45 of these had been in Yeovil Town centre.

One Member commented that the agreement was working reasonably well in Yeovil and that the retail establishments rang the PFRA to report instances of inappropriate activity.

In response to a member comment, the Licensing Officer confirmed that Yeovil Town Council held information for the collections taking place in Yeovil Town centre and that the District Council held this information for the remainder of the district.

Members were content that the agreement was working well and supported the recommendations outlined in the report.

## 50. Annual Update on the Licensing Service (Agenda Item 6)

The Licensing Officer summarised the report, which provided members with an annual update on the activities of the Licensing Service under the Licensing Act 2003, Gambling Act 2005 and Taxi Legislation for the financial year 2011/12.

During consideration of the report, Members noted the following:

- An application had been received to review the premises licence at 7 Bond Street, Yeovil. The review hearing was likely to take place on Friday 19<sup>th</sup> October at 2.00pm;
- An application had been received from Bruton Town Council for a review of the licence at Farmfest, Bruton on the grounds of the prevention of public nuisance, noise and public safety and pedestrian safety;
- Reference was made to the problems incurred with applications and permits under the Gambling Act 2005 as a lot of officer time was spent chasing up fees and lottery returns, despite non-statutory reminders having been sent. Further letters were sent out stating that a person guilty of an offence could be imprisoned for up to 51 weeks if they fail to submit a lottery return after a draw

had taken place. The registrations of those societies that did not pay the annual fee were cancelled in accordance with the Act;

- There had been no requirement for any hearing relating to applications made under the Gambling Act 2005. There tended to be more hearings held in seaside towns as they were often the result of applications to split the premises so as to obtain double the amount of gaming machines that is permitted at a premise;
- Since the report was published, licences had been issued for an Animal Boarding Establishment and for a Dangerous Wild Animal a Zebra;

Members were pleased to note the efficient running of the Licensing Service which they considered to be extremely well managed.
