

The District Council is the applicant for this scheme.

Site Description and Proposal



No 80 South Street is a Grade II listed building owned by the District Council.

Previously on the eastern elevation was a mural that had a hand and the writing "Arts Centre, exhibitions, day and evening classes, coffee shop". The arts centre has subsequently left this building and the mural has been covered over.

Yeovil Vision staff have moved into the premises and wish to have a mural with the Yeovil Vision logo and motto on the eastern elevation.

Considerations

There has previously been a mural on this wall and it advertises the use of the building. The Conservation Manager does not object to the proposal and it is considered to be acceptable.

Advertisement Consent is also required for the proposal due to the size of the mural. The application for this is considered below.

Recommendation

To recommend granting consent and refer to the Government Office of the South West (GOSW) for approval as the District Council owns the Listed Building, for the following reason:

Justification

01. The proposal is of a design in terms of materials, detailing and scale, which does not adversely affect the character of the Listed Building, in accordance with the aims and objectives of PPG 15 and Policy EH3 of the South Somerset Local Plan (Adopted April 2006).

Reg 3/4 Distr. permitted with conditions

01. The works hereby granted consent shall be begun before the expiration of three years from the date of this consent.

Reason: As required by Section 16(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990.

07/03410/R13 - Painting of a mural on east elevation. 80 South Street Yeovil - South Somerset District Council

The Committee considered this and the following application 07/03962/ADV together.

The Planner presented slides of the previous mural and that proposed for the end wall of the premises. She explained that the application for listed building consent had been recommended for refusal by Yeovil Town Council. However, the Town Council had agreed the application for the mural to advertise the Yeovil Vision. She said the Regulation Committee would be recommended to approve both applications.

The Committee agreed that the Regulation Committee be recommended to grant permission.
