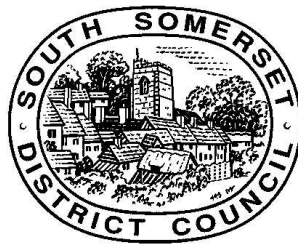


## Why is South Somerset District Council carrying out this review?

This Community Governance Review is being undertaken in accordance with the Local Government and Public Involvement in Health Act 2007.

Since 13 February 2008, district councils, unitary county councils and London borough councils ('principal councils') have had responsibility for undertaking community governance reviews and have been able to decide whether to give effect to recommendations made in those reviews. In making that decision, principal councils need to take account of the views of local people.

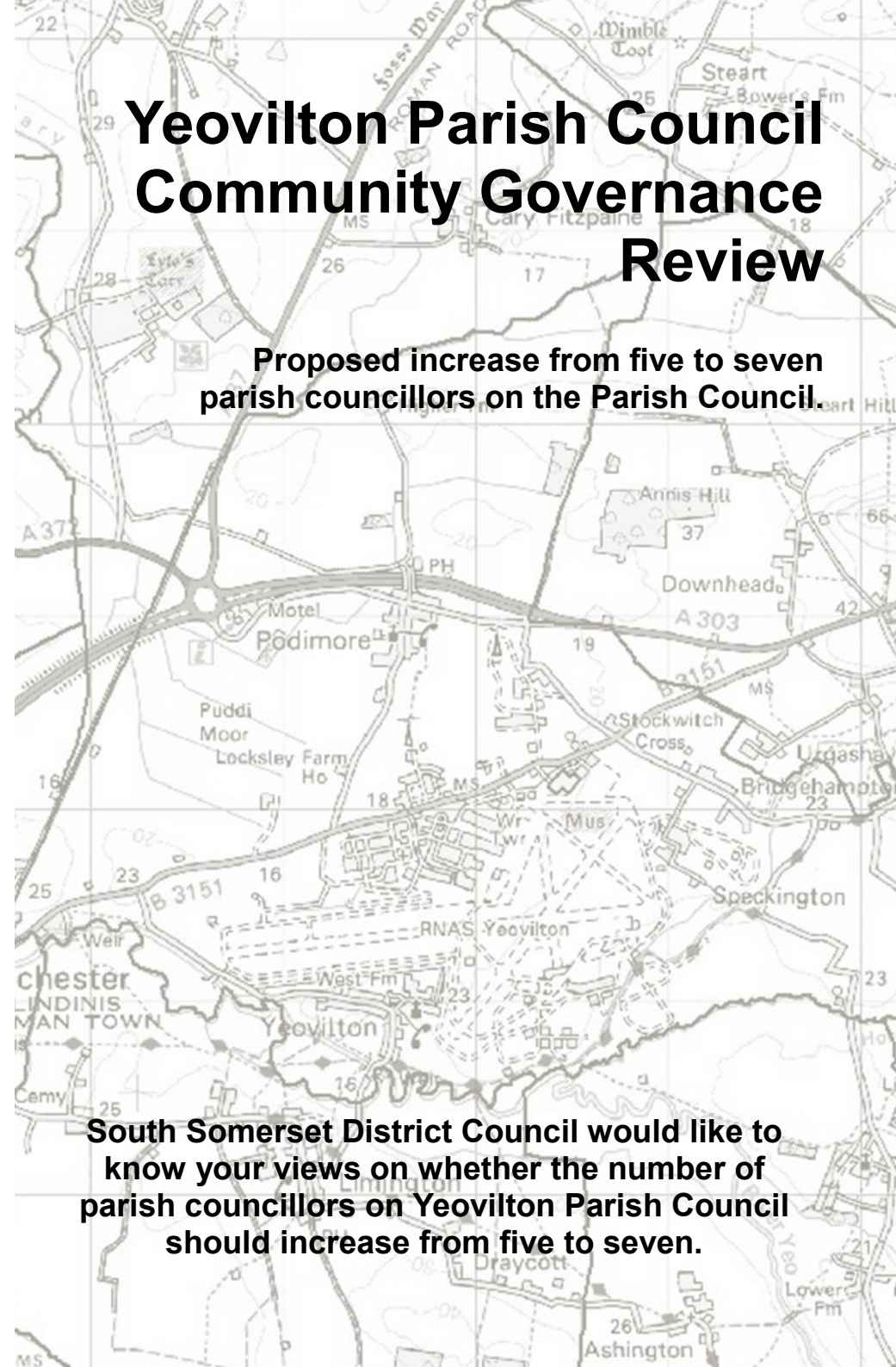

### Yeovilton Parish Council proposal:

The proposal of Yeovilton Parish Council is that the review should consider increasing the number of parish councillors on Yeovilton Parish Council from five to seven. In their request, the Parish Council state a number of reasons for wishing to increase the number of parish councillors including:

- At the 2015 Parish Council elections, an election was held as there were more candidates than vacancies.
- Two Councillors from the three areas of Yeovilton, Podimore and Bridgehampton would be a better balance and make it easier to guarantee a quorum at meetings.
- Future development of RNAS Yeovilton and its impact on the local community.

## Why are we consulting you?

South Somerset District Council has to undertake a review relating to the proposals to increase the number of councillors on Yeovilton Parish Council as a valid request has been made by the Parish Council to do so. The enclosed map shows the area affected being that of the existing boundary of Yeovilton Parish Council. The area has an electorate of 332 people.

The aim of this review is to look at the most suitable arrangements for representing the people of the parish and to decide whether an increase in the number of parish councillors would be the best means of:

- Representing the interests and identities of local people
- Providing a range of local government services

South Somerset District Council, once we receive your views, will consider the results of the consultation exercise and will publish a set of proposals in July 2016. There will be a further opportunity to comment on these draft proposals.

## If agreed, when will it take effect?

If the majority of responses from local people of the parish are in favour of the proposal, then South Somerset District Council will notify the Electoral Commission of the new arrangements. The change would normally take effect from the next local election in May 2019.

## What does a Parish Council do?

Parish Councils are democratically elected bodies that have statutory powers which can include the provision of allotments, bus shelters, support for local crime prevention initiatives, cemeteries, play areas and open spaces.

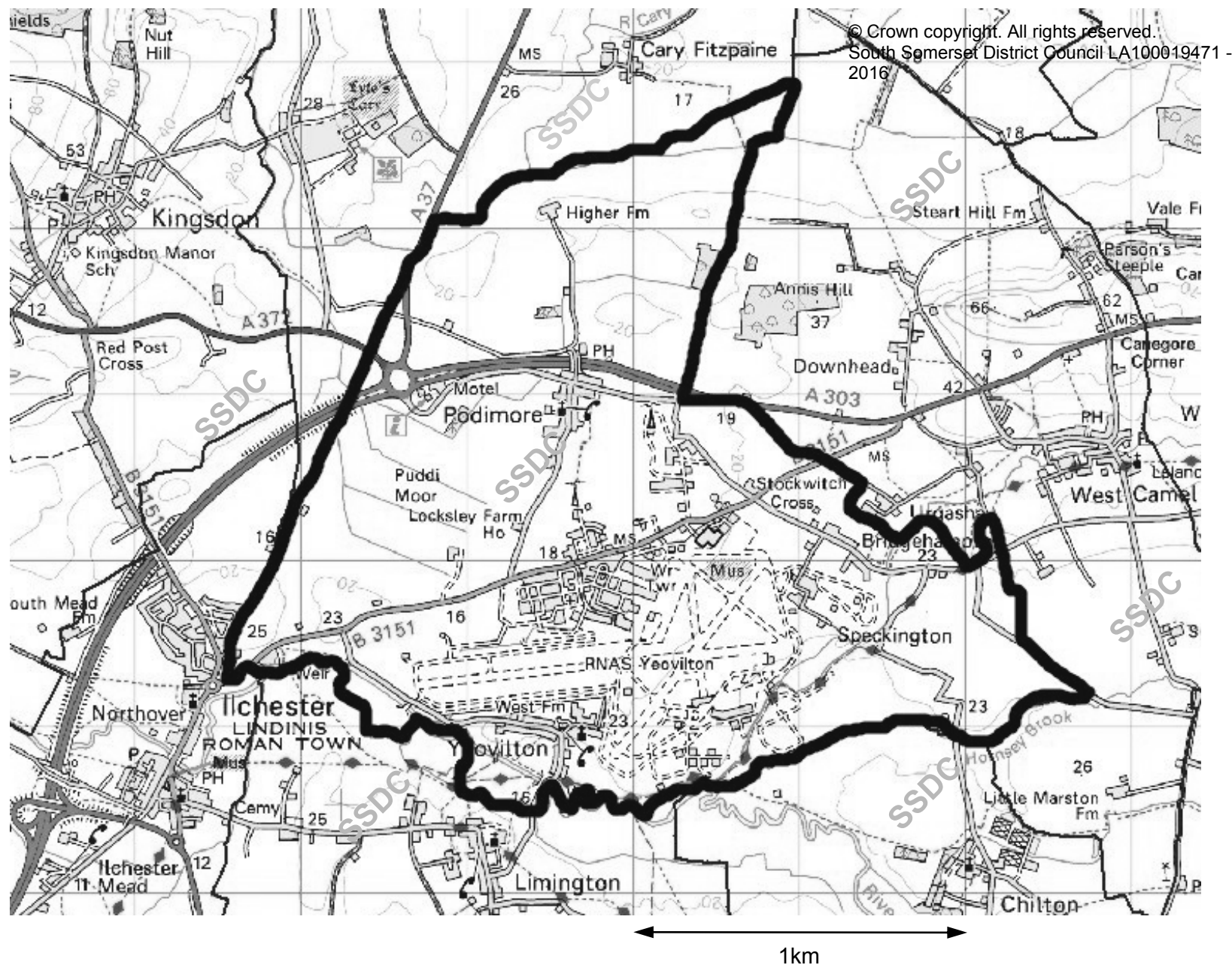
They are also often involved in the provision and maintenance of community transport schemes, sport and recreation facilities and tourism. For Yeovilton Parish Council, the main activities include: Providing a focus for representing local issues and identity, highways liaison and traffic calming, rights of way, planning, local health and wellbeing and local events.

The proposed increase in the number of parish councillors will not have any additional impact upon your Council Tax.
