Stoke Trister with Bayford Parish Council proposal:

In their request, the Parish Council state that when the A303 dual-carriageway/Wincanton by-pass was built, it went through the middle of Leigh Common, dividing the Common. In recompense the Department of Transport (as it was then) purchased some land to the south of the new road and Beech Lane. However, this land was not in the parish of Stoke Trister with Bayford but in Pen Selwood parish.

Now that the land registration has been resolved, the two parishes wish to change the parish boundary so that the whole of Leigh Common is within Stoke Trister Parish. There are no residential properties on this land and consequently no local electors will be affected. Stoke Trister with Bayford currently manages the Common and two of the fields are let for grasskeep from April to November to gain revenue for their upkeep. The whole of Leigh Common is in the ownership of Stoke Trister with Bayford Parish Council.

Pen Selwood Parish Council has confirmed they are in agreement with the request.

Why are we consulting you?

South Somerset District Council has to undertake a review relating to a boundary change proposal between Pen Selwood Parish Council and Stoke Trister with Bayford Parish Council, as a valid request has been made by the Stoke Trister with Bayford Parish Council to do so. The enclosed maps show the area affected being that of the existing boundary between the two parish councils. Stoke Trister with Bayford has 257 electors and Pen Selwood has 287.

The aim of this review is to look at the most suitable arrangements for representing the people of the two parishes and to decide whether a change in the parish boundary would be the best means of:

- Representing the interests and identities of local people
- Providing a range of local government services

South Somerset District Council, once we receive your views, will consider the results of the consultation exercise and will publish a set of proposals in late autumn/winter 2011. There will be a further opportunity to comment on these draft proposals.

What does a Parish Council do?

Parish Councils are democratically elected bodies that have statutory powers which include the provision of allotments, bus shelters, support for local crime prevention initiatives, cemeteries, play areas and open spaces.

They are also often involved in the provision and maintenance of community transport schemes, sport and recreation facilities and tourism. They provide a focus for representing local issues and identity.

The proposed change to the parish council boundary between Pen Selwood Parish Council and Stoke Trister with Bayford Parish Council will not affect any properties or electors. There would be no cost to the Parish Council and it will not have any additional impact upon your Council Tax.

Location of proposed change to the Parish Council boundary.

The dotted purple line indicates the existing parish boundary between Pen Selwood and Stoke Trister with Bayford. The proposed change to the parish boundary between the two parishes is indicated by the dotted orange line.

Leigh Common is indicated as a solid dark green colour. The proposed change to the parish boundary would mean the whole of Leigh Common is within one parish - Stoke Trister with Bayford.
